

End-of-Sale for ReachNXT AC Power Adapter

This document is the notification of the pending end-of-sale of the ReachNXT AC Power Adapter (12102) worldwide.

The compact and quiet ReachNXT 100-8t enterprise port extender provides 8 Fast Ethernet ports plus 1 Gigabit Ethernet combo copper/SFP fiber port. The ReachNXT 100-8t will operate only if connected to an upstream ExtremeXOS switch. It is a fan-less design for low-noise environments. The ReachNXT can be powered via Power over Ethernet (PoE) provided by a switch or an optional AC adapter.

Due to new regulations already in place in the United States and new regulations going into effect in EMEA, the AC power adapter (12102) can/will no longer be able to be shipped into these geographies, so Extreme Networks® is announcing the End of Sale of the ReachNXT power adapter. Since the vast majority of the ReachNXT 100-8ts are deployed using PoE, Extreme has chosen not to test/certify a replacement power supply. Extreme does have inventory in its warehouses that can be shipped to customers in these geos and believes it is adequate to satisfy the demand for the next two quarters.

Replacement Products

There is no direct replacement for the optional AC power adapter. The only options for powering the ReachNXt 100-8t is Power over Ethernet (PoE) provided by an upstream ExtremeXOS switch or a midspan power injector.

Existing contracts may be renewed during the first 4 years of the end-of-support period, provided that during the period following the end-of-sale date, the hardware replacement services provided do not include any 4-hour or onsite services, and that the contract expiration date does not extend beyond the end-of-support date as specified above. During the support period, replacement of product and/or repairs may be limited by availability of components.
