

Update to End-of-Sale Notification for 7100/7100G Series Switch Family

This End of Sale notification is intended to announce the End of Sale for 7100 and 7100G Switches on May 30, 2019.

Update 5/23/2019; The end of sale date for 7100-Series SKUs identified below is being extended to July 31, 2019. Note that this notice represents extension of the End of Sale date (only) for the identified SKUs; the End of Software Maintenance and End of Service Life dates will remain as previously defined, as shown below.
