

Update to End-of-Sale Notification for K-Series Modular Switch Family

April 30, 2019

This End of Sale notification is intended to announce the End of Sale for K-Series Switches on April 30, 2019.

Update 4/25/2019; The end of sale date for K-Series SKUs identified below is being extended to July 31, 2019. Note that this notice represents extension of the End of Sale date (only) for the identified SKUs; the End of Software Maintenance and End of Service Life dates will remain as previously defined, as shown below.

The End of Sale date for a number of SKUs will remain at 4/30/2019 as there is no remaining inventory as noted below.
