Retroactive End-of-Sale Notification for ES-6510

The ES-6510 is a three port Ethernet wall switch. Designed as a companion to the AP-6511, the ES-6510 was installed in alternating hotel guest rooms when the AP-6511 was installed one in every other room. As the AP density increased, the need for the ES-6510 has dropped off.

The single radio AP-6511 was announced EOS on PMB 2741 for most markets. The ES-6510 End of Sale milestones should align with PMB 2741. This retroactive End of Sale Notification aligns the ES-6510 with the PMB 2741.

Several wall plate access points with Ethernet ports are available as a replacement for the AP-6511 and ES-6510. For example, the AP-7502 or AP-7602 are designed for slightly different applications of a wallplate access point. Both the AP-7502 and AP-7602 provide new features and capabilities not available on the AP-6511 and ES-6510 products.
